On July 28, 2020, Oregon Department of Education released updated guidance in coordination with the Oregon Health Authority and the Oregon Governor's office. This guidance provides specific state and county-wide metric requirements for in-person and/or hybrid instruction to occur. Until those metrics are met on a regional and state level, by necessity, the Migrant Education Program will follow the Comprehensive Distance Learning guidance to provide direct services to students and families.

All schools that the Region 26 East Multnomah County Migrant Education Program are active in (Centennial, Corbett, David Douglas, Gresham-Barlow, Parkrose and Reynolds) reside within Multnomah County. This means that the Migrant Education Program will begin service for the 2020-2021 school year in distance learning mode in September 2020. When OHA and ODE requirements are met in Multnomah County and Oregon, the Migrant Education Program will reach out to stakeholders to determine the exact timeline for initiating the hybrid model after the indicators are met. The Migrant Education Program will work to coordinate district-specific models based on stakeholder feedback as well as the preferred model used by each of the above-mentioned districts.

Planning and choosing an instructional model for the Migrant Education Program 2021 Summer School will not be done at this time. This is because requirements and guidance will change throughout the year. The Migrant Education Program will create a timeline during the regular school year that includes sufficient time for feedback from stakeholders, staff and students.

The goal of the Migrant Education Program (MEP) is to transition to a hybrid/fully in-person instructional model as soon as it is safe to do so and following each of the previously mentioned districts' specific instructional models. Until that time, the MEP will be following the guidelines set forth by ODE for Comprehensive Distance Learning.

Our CDL model will be loosely based on our model developed in the Spring but with an increased alignment to the Migrant Education Programs Service Delivery Plan (SDP), a greater focus on equity and additional support for families and students.

The MEP finalized plan will be available on August 17th and will address more logistical details.

In the meantime, the MEP would like to highlight a few key areas of support:

Recruiting:

All interviews with families and students will be done via telephone at this time. All Certificates of Eligibility (COE) will be done online and no longer on paper. Guardian signatures are allowed to be replaced with the text "COVID-19 call" and accompanied with a comment stating "Due to the pandemic, the interviewee [insert name], [insert relationship to student], verified by phone the eligibility information on [insert date]."

Families in need of food box delivery can continue to contact a MEP staff member by phone or text. A MEP staff member will deliver the food box and follow safety guidelines described below.

Preschool:

Preschool services will continue to be delivered remotely through Youtube, Class Dojo, phone calls, and texts. Materials will be dropped off at homes for families and preschool students who can then access lessons on their phone or computer. Hyperlinks to recorded lessons will continue to be texted to families as well as posted on the MEP social media accounts.

Graduation:

Direct services for middle and high school students will be done following the CDL model. The Graduation Specialist and Middle School Mentor will continue communication and student support through phone calls, texts, and in the case of incoming 6th grade students, letters. The MEP will continue to look into the idea of utilizing Google Classrooms or another such platform to create a central message board for staff to post important reminders to students for such things as forecasting, FAFSA and scholarships.

All currently eligible migrant students are able to access a Stride Academy account to support Math and Language Arts learning for the school year. Those students who were enrolled in the 2020 MEP summer program will continue to have access to their account. For those new students, an account will be made for them. Login information will be sent out in paper as well as text and social media. Instructions on how to access Stride are provided in English and Spanish along with videos in Spanish on how to login. Students in Kindergarten through eighth grade will be encouraged to access Stride to supplement district-provided learning.

Family Engagement:

Families and students will continue to be supported by the MEP. Support may look different depending on the needs of the family and students but may include:

- delivery of food boxes/referral to food delivery service
- facilitation of communication of school plans for re-opening (helping families access surveys online themselves or having a MEP staff member complete the survey for the family over the phone or in person while following OHA guidelines.
- aid communication and support family questions regarding technology needs and access to internet

The format for this year's Parent Night meetings will be developed in September and October after MEP staff has consulted with the Parent Advisory Council (PAC) and done a survey to determine families' needs to access an online meeting. One idea currently is to host a bi-weekly or once a month "Cafe y Charlar" meeting in which families could connect and build community, share questions and answers and support one another.

- Process to report to the LPHA any cluster of any illness among staff or students.
- Protocol to cooperate with the LPHA recommendations and provide all logs and information in a timely manner.
- Protocol for screening students and staff for symptoms (see section 1f of the **Ready Schools, Safe Learners** guidance).
- Protocol to isolate any ill or exposed persons from physical contact with others.
- Protocol for communicating potential COVID-19 cases to the school community and other stakeholders (see section 1e of the **Ready Schools, Safe Learners** guidance).

- Protocol to record/keep daily logs to be used for contact tracing for a minimum of four weeks to assist the LPHA as needed.
- Process to ensure that the school reports to and consults with the LPHA regarding cleaning and possible classroom or program closure if anyone who has entered school is diagnosed with COVID-19.

- Staff and school administrators, in partnership with school nurses, or other school health providers, should work with interdisciplinary teams to address individual student needs. The school registered nurse (RN) is responsible for nursing care provided to individual students as outlined in ODE guidance and state law:
 - Communicate with parents and health care providers to determine return to school status and current needs of the student.
 - Coordinate and update other health services the student may be receiving in addition to nursing services. This may include speech language pathology, occupational therapy, physical therapy, as well as behavioral and mental health services.
 - Modify Health Management Plans, Care Plans, IEPs, or 504 or other student-level medical plans, as indicated, to address current health care considerations.
 - The RN practicing in the school setting should be supported to remain up to date on current guidelines and access professional support such as evidence-based resources from the Oregon School Nurses Association.
 - Service provision should consider health and safety as well as legal standards.
 - Work with an interdisciplinary team to meet requirements of ADA and FAPE.
 - High-risk individuals may meet criteria for exclusion during a local health crisis.
 - Refer to updated state and national guidance and resources such as:
 - US Department of Education Supplemental Fact Sheet: Addressing the Risk of COVID-19 in Preschool, Elementary and Secondary Schools While Serving Children with Disabilities from March 21, 2020.
 - ODE guidance updates for Special Education. Example from March 11, 2020.
 - OAR 581-015-2000 Special Education, requires districts to provide 'school health services and school nurse services' as part of the 'related services' in order 'to assist a child with a disability to benefit from special education'.
 - OAR 333-019-0010 Public Health: Investigation and Control of Diseases: General Powers and Responsibilities, outlines authority and responsibilities for school exclusion.

Visitors/Volunteers:

Visitors/Volunteers will be unable to work in schools, or complete other volunteer activities that require in person interaction, at this time. Adults in schools are limited to essential personnel only.

- Face masks for school RNs or other medical personnel when providing direct contact care and monitoring of staff/students displaying symptoms. School nurses should also wear appropriate Personal Protective Equipment (PPE) for their role.
- Students who choose not to wear face coverings must be provided access to instruction.**
- ADA accommodations:** If a staff member requires an accommodation for the face covering or face shield requirements, districts and schools should work to limit the staff member's proximity to students and staff to the extent possible to minimize the possibility of exposure.

- Symptomatic staff or students should seek COVID-19 testing from their regular physician or through the local public health authority.

Full-Time Online and/or Hybrid school students: Full-time students who are enrolled in school and taking online and/or hybrid courses only are reported on an FTE basis using a standard record (ADMProgTypCd = 01) as identified in the Oregon Cumulative Average Daily Membership (ADM) Manual. This is an existing policy previously used in the online setting. As such, there should not be any need to reprogram student information systems to accommodate for this change and the addition of the hybrid setting.

- Note: Because the students in the online and/or hybrid setting do not regularly attend classes at the district facilities, the standard procedures for recording student days present and days absent cannot be effectively applied to those students. This will reduce accuracy of attendance data for the state while this is in effect.
- For the purposes of this section, please use the following definition and clarification: **Online and/or Hybrid Check-in:** The responsibility of taking attendance must be performed by the teacher of record. "Check-ins" with appropriately licensed instructional staff are two-way communications between the student and the teacher. A check-in does not include a student leaving a message on an answering machine or sending an email that does not receive a response from the appropriately licensed instructional staff by the end of the next school day.
- The student must check-in **at least** twice a week with their teacher(s) of record on **at least** two separate weekdays in order to be counted as present for all five days of that week.
- If the student only checks in once during the week, the student must be counted as absent for half of the scheduled week (2.5 days, if there are 5 days scheduled in the week).
- The student must be counted as absent for the entire week (5 days, if there are 5 days scheduled in the week) if they do not report in at all during the week.
- Note: If a district schedule is based on a 4-day school week, the student would still need to check in twice a week as described above in order to be counted as present for the entire week (4 days) and once a week to be counted as present for half of the week (2 days).
- Days in attendance may not be claimed for days in which the student did not have access to appropriately licensed instructional staff. The purpose of the rule regarding checking in with the teacher of record is to assure that the teacher can evaluate whether the student is making adequate progress in the course and the student has additional guaranteed opportunities to engage with a teacher. The responsibility of taking attendance must be performed by the teacher of record, not another staff member (e.g., the registrar or school secretary).

Part-time students receiving online and/or hybrid instruction (not college courses): Students who are not enrolled full-time and are taking online and/or hybrid courses offered by the school district or charter school are reported as large group instruction (program type 4), unless they are an ESD-registered homeschooled or private school student receiving supplemental coursework in public school, which are reported as shared time (program type 9). The district may count up to 1 hour per day per course taken, provided appropriately licensed teachers for the coursework taken, are available and
