On July 28, 2020, Oregon Department of Education released updated guidance in coordination with the Oregon Health Authority and the Oregon Governor's office. This guidance provides specific state and county-wide metric requirements for in-person and/or hybrid instruction to occur. Until those metrics are met on a regional and state level, by necessity, the Migrant Education Program will follow the Comprehensive Distance Learning guidance to provide direct services to students and families.

All schools that the Region 26 East Multnomah County Migrant Education Program are active in (Centennial, Corbett, David Douglas, Gresham-Barlow, Parkrose and Reynolds) reside within Multnomah County. This means that the Migrant Education Program will begin service for the 2020-2021 school year in distance learning mode in September 2020. When OHA and ODE requirements are met in Multnomah County and Oregon, the Migrant Education Program will reach out to stakeholders to determine the exact timeline for initiating the hybrid model after the indicators are met. The Migrant Education Program will work to coordinate district-specific models based on stakeholder feedback as well as the preferred model used by each of the above-mentioned districts.

Planning and choosing an instructional model for the Migrant Education Program 2021 Summer School will not be done at this time. This is because requirements and guidance will change throughout the year. The Migrant Education Program will create a timeline during the regular school year that includes sufficient time for feedback from stakeholders, staff and students.

The goal of the Migrant Education Program (MEP) is to transition to a hybrid/fully in-person instructional model as soon as it is safe to do so and following each of the previously mentioned districts' specific instructional models. Until that time, the MEP will be following the guidelines set forth by ODE for Comprehensive Distance Learning.

Our CDL model will be loosely based on our model developed in the Spring but with an increased alignment to the Migrant Education Programs Service Delivery Plan (SDP), a greater focus on equity and additional support for families and students.

In the meantime, the MEP would like to highlight a few key areas of support:

Recruiting:

All interviews with families and students will be done via telephone at this time. All Certificates of Eligibility (COE) will be done online and no longer on paper. Guardian signatures are allowed to be replaced with the text "COVID-19 call" and accompanied with a comment stating "Due to the pandemic, the interviewee [insert name], [insert relationship to student], verified by phone the eligibility information on [insert date]."

Families in need of food box delivery can continue to contact a MEP staff member by phone or text. A MEP staff member will deliver the food box and follow safety guidelines described below.

Preschool:

Preschool services will continue to be delivered remotely through Youtube, Class Dojo, phone calls, and texts. Materials will be dropped off at homes for families and preschool students who can then access lessons on their phone or computer. Hyperlinks to recorded lessons will continue to be texted to families as well as posted on the MEP social media accounts.

Graduation:

Direct services for middle and high school students will be done following the CDL model. The Graduation Specialist and Middle School Mentor will continue communication and student support through phone calls, texts, and in the case of incoming 6th grade students, letters. The MEP will continue to look into the idea of utilizing Google Classrooms or another such platform to create a central message board for staff to post important reminders to students for such things as forecasting, FAFSA and scholarships.

All currently eligible migrant students are able to access a Stride Academy account to support Math and Language Arts learning for the school year. Those students who were enrolled in the 2020 MEP summer program will continue to have access to their account. For those new students, an account will be made for them. Login information will be sent out in paper as well as text and social media. Instructions on how to access Stride are provided in English and Spanish along with videos in Spanish on how to login. Students in Kindergarten through eighth grade will be encouraged to access Stride to supplement district-provided learning.

Family Engagement:

Families and students will continue to be supported by the MEP. Support may look different depending on the needs of the family and students but may include:

- delivery of food boxes/referral to food delivery service
- facilitation of communication of school plans for re-opening (helping families access surveys online themselves or having a MEP staff member complete the survey for the family over the phone or in person while following OHA guidelines.
- aid communication and support family questions regarding technology needs and access to internet

The format for this year's Parent Night meetings will be developed in September and October after MEP staff has consulted with the Parent Advisory Council (PAC) and done a survey to determine families' needs to access an online meeting. One idea currently is to host a bi-weekly or once a month "Cafe y Charlar" meeting in which families could connect and build community, share questions and answers and support one another.

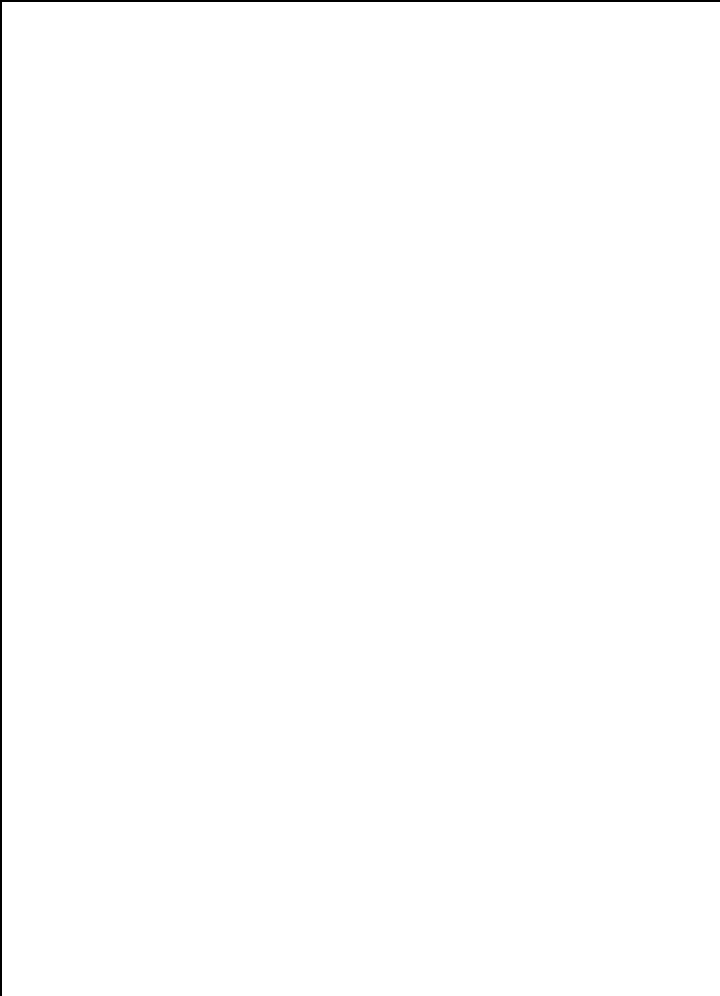
